# SNAPSHOT

## **MODULE I - Contract Management under the FIDIC Conditions of Contract**

This course gives an introduction to the FIDIC Red Book, Yellow Book, and Silver Book (1<sup>st</sup> Edition 1999 **and** 2<sup>nd</sup> Edition 2017). Its main focus lays on the explanation of all FIDIC procedures with regard to Time for Completion, Testing, Taking-Over, Payments and Claims. A further core aspect is to explain the legal wording against its background for further use in civil law jurisdictions.

## **MODULE IV - Contract Management & Administration**

This training course is designed and fully built upon 2017 forms of Contract to provide participants with increased confidence in working with FIDIC's major construction contract forms whether representing Employers, Consultants or Contractors. The face-to-face mainly focuses on contractual step-by-step mechanisms, project management tools of FIDIC's major contract forms and best practices.

## **MODULE II Contract Claims and Disputes**

This course goes through the claims' procedures and claims including the change clause. It covers CPM issues, concurrency problems, delay analysis, causation issues and quantum problems. Contractor's views and Engineer's views will be discussed. Finally the course will show how a DAB works and explain typical situations in claim preparation and dispute management and resolution.

## **MODULE III Dispute Adjudication**

This course will give a sophisticated view on Dispute Resolution practice under FIDIC Contracts (1<sup>st</sup> Edition 1999 **and** 2<sup>nd</sup> Edition 2017). The course intends to explain dispute avoidance practices and problems as well as the appointment of DABs, preparation of referrals, conduct of hearings and decision making.

### OVERVIEW
